Section 5. Fire-fighting measures

Personal precautions, protective equipment and emergency procedures

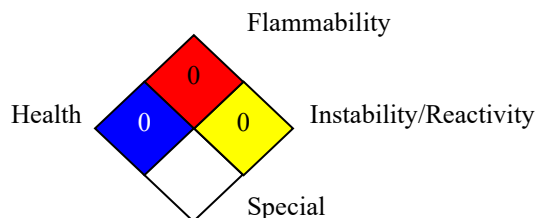
